The *Journal of Defence Studies* is a quarterly, refereed journal published by the IDSA in January, April, July and October of each year. The maximum time allowed for Execution of Work for each issue is **40 days**. The Work includes the following:

- (a) Typesetting
- (b) Proofs (2-3 rounds)
- (c) printing
- (d) delivery of stock to IDSA on agreed upon date
