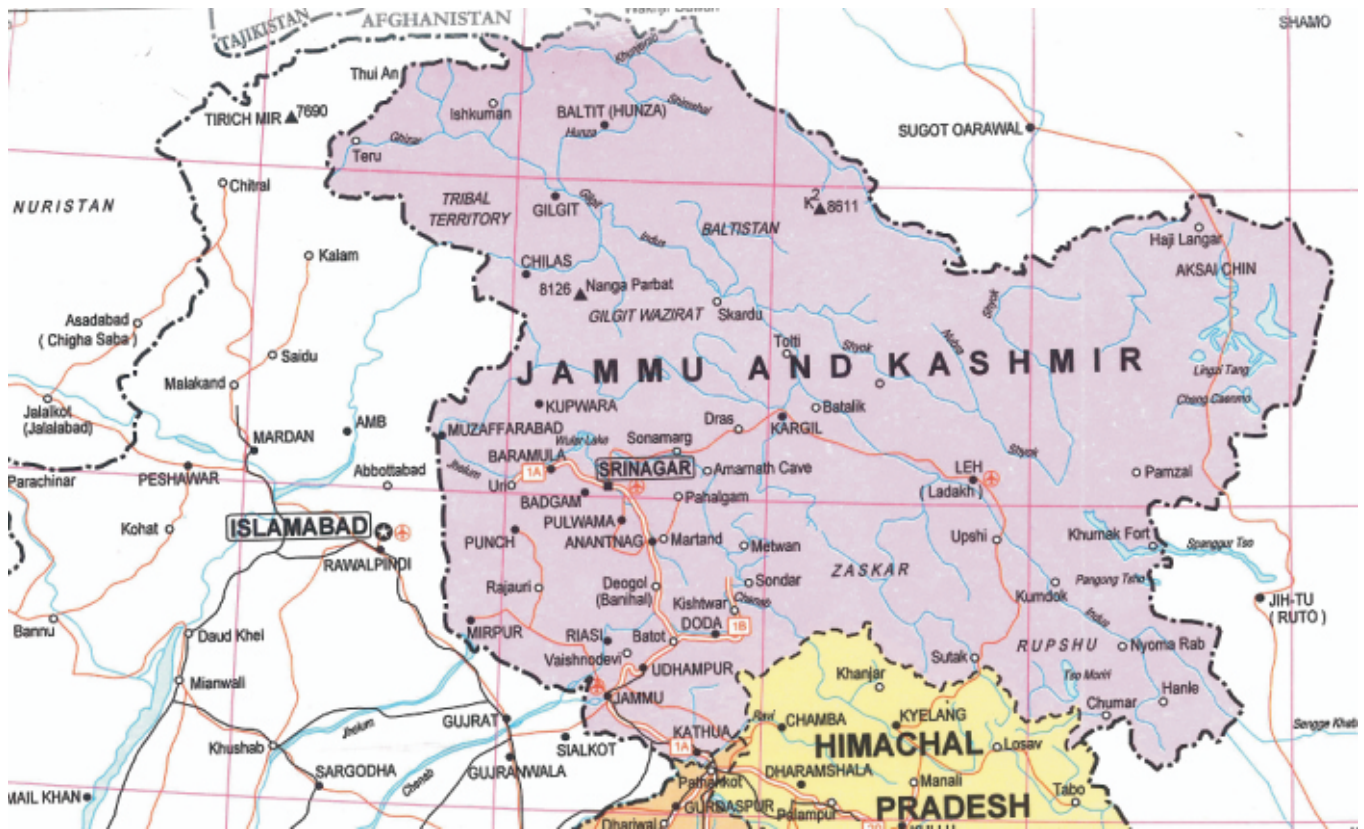

In this Edition

The current issue is dominated by the economic developments taking place inside PoK. Pakistan is keen to tap the resources available in PoK and therefore directing efforts to develop it into an industrial and investment hub. Pakistan's intent is reflected in one the reports included in this issue which describes the demand to set up investment centers in AJK to facilitate local and foreign investment. It is felt that lack of banking channels and facilities in AJK have held back the development of the industrial sector in the region and there is need to encourage more financial institutions to promote the economic sector in PoK. These views were expressed in a seminar held in Mirpur, organized by the State Bank of Pakistan in collaboration with certain banks.

There was uncertainty over the schedule of general elections in AJK. Initially May 25, 2011 was tentatively decided to be the date of elections. Later however, the Election Commission in AJK announced the elections would be held anytime between last week of June and first week of July, 2011. There was some controversy hovering early dissolution of the Legislative Assembly in the AJK for having early elections.

On the cross LoC trade between J&K and PoK, both India and Pakistan are trying to arrive at a certain understanding on the number of truck passing across so as to ensure security and make management of trucks efficient and quick. Notably, the huge number of trucks passing through LoC (ever since October 2008) has complicated the security formality which as it is a time consuming process.

Political Developments

Elections in AJK likely on May 25

ISLAMABAD: The general elections in Azad Jammu and Kashmir are likely to be held on May 25 and the governments of Pakistan, AJK and political parties have reportedly reached an informal understanding in this regard. Informed political sources stated that a formal announcement regarding May 25 as date for holding general elections in AJK was yet to be made but the top government functionaries had already chosen the aforementioned date for this purpose.

The conduct of early elections through dissolution of AJK Legislative Assembly had been a subject of controversy in the AJK political circles. In August 2010, senior PML-N AJK leader and former AJK Prime Minister, Raja Farooq Haider accused AJK PM Sardar Attique Ahmad Khan of mulling over dissolving the AJK Legislative Assembly to hold early elections. A move, Farooq alleged, aimed at adversely affecting the PML-N by denying it the time to prepare for general elections. In addition, former Speaker AJK LA, Shah Ghulam Qadir, had accused the AJK PM of planning to dissolve the AJK LA and hold early polls in order to abolish AJK's administrative character and make it Pakistan's province on de facto patterns the way Gilgit-Baltistan was declared province.

Tariq Naqash, Polls after last week of June: PAK EC

MUZAFFARABAD: Pakistan Administered Kashmir Election Commission in Muzaffarabad on March 15 retracted its earlier statement on the

forthcoming general election to the Legislative Assembly, stating the polls could only be held between the “last week of June and first week of July.”

Earlier in February, the EC had said that general election could be held anytime between May 23 and July 9 and that it would be ready to announce the election schedule after April 15.

According to section 22 (4) of the PaK's Interim Constitution, “General election to the Assembly shall be held within a period of 60 days immediately preceding the day on which the term of the Assembly is due to expire, unless the Assembly has been sooner dissolved, and the result of the election shall be declared not later than 14 days before that day.”

Tourism promotion in GB not govt priority

ISLAMABAD: The northern areas of Pakistan are like canvases that portray the joy and contentment bestowed by the inexhaustible beauty of nature's boundless forms. But the beautiful valleys miss their admirers who once used to visit in great numbers to watch and bask in the glory of nature. That is because tourism has failed to reach its full potential in Gilgit-Baltistan, conceded experts associated with the industry in the Ministry of Tourism as well as those in Parliament. Experts in the tourism industry pointed fingers at the government for mismanagement of policies despite the fact that tourism was the largest industry in Gilgit and all the way to Hunza and beyond.

“It's just not government's priority,” noted Senator Pervaiz Rashid, who is member of the Senate standing committee on culture and tourism, citing

his reason for the held-back growth. Tourism could play a key role in the region's future economy, he stated, adding: "But the industry needs stronger, clearer support from the government to reach its full potential. And that we fear does not seem coming".

Pakistan building colony for Chinese in PoK

March 2, 2011

In an indication of Beijing's strengthening ties with Islamabad, Pakistan is constructing a colony of about 20 buildings for Chinese workers in Chattar area of occupied Kashmir's Muzaffarabad district. The construction, confirmation of which came ahead of Prime Minister Manmohan Singh's Beijing visit in April for a meeting to welcome South Africa into the Brazil, Russia, India and China (BRIC) group, will ensure a permanent footprint for China very close to India. Sources stated the settlement was being built on approximately four acres for Chinese workers involved in construction activities in the region.

Last year, New Delhi had objected to reported presence of 11,000 People's Liberation Army (PLA) of China personnel in the strategic Gilgit-Baltistan region of Pakistan-occupied Kashmir (PoK). The ministry of external affairs stated it would seek independent verification of PLA soldiers working on a project in the region which would give China rail and road access to the Gulf to transport cargo and oil.

Other reported construction activities in the region include extension of the Karakoram highway to link China's Xinjiang autonomous province with Pakistan, dams and expressways. Experts in New Delhi stated by increasing presence in the Gilgit-Baltistan area, China was adding to the strategic threats in Leh-Kargil. They noted this would necessitate greater attention to development of infrastructure in the sector and a review of New Delhi's interactions with the nationalist elements in Xinjiang and Gilgit-Baltistan.

Bhasha Dam security: GB govt to induct 600 scouts

GILGIT: The federal government would induct 600 personnel in the Northern Area Scouts to provide foolproof security to the workers during the construction of Diامر-Bhasha Dam. A statement issued by the chief minister secretariat on March 4 disclosed the decision was taken at a meeting between chief minister GB and chairman Wapda in

Islamabad. Wapda chairman informed Syed Mehdi Shah that 600 scouts would be appointed to safeguard the engineers and labourers to be engaged with construction work on Diamer-Bhasha Dam.

The Wapda chief also assured of upgrading the district headquarters hospitals of Chilas, Skardu, and Gilgit and setting up a state-of-the-art public school in Skardu. The statement noted that Wapda also promised to release within 15 days Rs2.20 billion in respect of land compensation to the landowners.

PEACE IN GB: Members of the Parliamentary Committee of Gilgit-Baltistan Legislative Assembly on March 4 met the top religious scholars of Gilgit and appealed to them to play their role in establishing peace in the area, which has witnessed sectarian violence, official sources stated.

Shabbir Mir, Contemptuous comments: G-B institutes first-ever blasphemy case

GILGIT: Gilgit-Baltistan joined the league of Pakistan's other self-righteous areas after the region's first-ever blasphemy case was registered against a man who allegedly passed "contemptuous comments against the Holy Prophet Muhammad (Pbuh)". "A case has been registered under the blasphemy law against Yaqoob, son of Taifur Shah," Sultan Azam, the superintendent police noted outside the city police station where hundreds of protesters blocked the main road, calling for punishing the alleged accused. Without being specific, a police official said that the man was not a Christian. Abdur Rauf, a resident of Kondas in Gilgit, had submitted an application with the city police station in the evening stating he was a witness to the crime.

Yaqoob is said to be a resident of Ghizer Valley, which is about 75 kilometers from Gilgit. SP Azam stated that the man had been arrested and police had started an investigation into the case. The incident

was reported in Kondodas and the news spread like wildfire. Hundreds of people gathered outside the police station, calling for the man's immediate arrest. As the crowd grew larger, shopkeepers closed their shops in anticipation of violence. The crowd, however, dispersed peacefully after police registered a case under the sections 295, 296, 298, 500, 506 of the Pakistan Penal Code (blasphemy law).

JKLF wants Gilgit-Baltistan merged with AJK

LONDON: Sardar Muhammad Saghir Khan Advocate, Chairman of Jammu and Kashmir Liberation Front (JKLF), stated that the right to decide the future status of the state entirely rests with the people of Jammu and Kashmir and this rights must be respected by all stakeholders.

This is the first visit of any senior JKLF leader to Britain after the party's leadership was expelled from the country following Indian diplomat Ravindra Mhatre's murder case in February 1984 in Birmingham. Saghir Khan said he was pleased to be in Britain where the JKLF was once a strong organisational unit but faced defections and split after Amanullah Khan was expelled from Britain. Speaking at a press conference in London organised by JKLF's London unit, Khan stated that since 1947 the people of Kashmir have struggled against forced division and occupation of their motherland. "Since 1947, 17 million people of Jammu and Kashmir, remain denied of this basic right-the right to choose and the right to freedom. The entire state of Jammu and Kashmir remains divided with a heavy military deployment on both sides of the Line of Control," he noted. He asked the government of Pakistan to undo the damage by uniting Gilgit Baltistan with the AJK territory, to form a truly independent and democratic revolutionary government that would be an independent voice to advocate for the freedom and reunification of the entire state and would also address the day to day needs of the citizens of the unified Gilgit Baltistan and AJK regions.

Ministry seeks waiver for 1,100MW Kohala hydropower project

The Ministry of Water and Power is seeking a waiver from the Economic Coordination Committee (ECC) of the Cabinet for the execution of 1,100MW Kohala Hydropower project through private sector under Power Generation Policy 2002, as stated in a summary. The draft summary seeks a waiver to the requirement of solicitation through advertisement as the project was awarded to CWE, a private company, pursuant to an MoU duly approved by the Cabinet.

The ECC, while reviewing the implementation status of the decisions made in its March 1 meeting, desired the case to be brought before it, if there were some hurdles. In the light of this, the Ministry has submitted the case before ECC for implementation of the project in private sector.

The Economic Coordination Committee (ECC) of the Cabinet, on October 15, 2010, considered a summary by Ministry of Water and Power for development of 1,100 MW project in Azad Jammu and Kashmir. The ECC constituted a committee comprising Minister for Water and Power, Minister for Petroleum and Natural Resources, Secretary Finance, Secretary Economic Affairs Division, Secretary Water and Power and Managing Director of Private Power Infrastructure Board (PPIB).

Roshan Mughal, Hydroelectric power: WAPDA alleges rules were flouted in award of contract

MUZAFFARABAD: Pakistan and China are trapped in a deadlock over the construction of the 1,100 megawatts (MW) Kohala Hydropower Project on the Jhelum River in Azad Jammu and Kashmir (AJK) due to Wapda's intransigence.

The contract was awarded to a Chinese construction company, China International Water and Electric Corporation (CWE). Wapda accuses decision makers of violating Pakistan Power Regulatory Authority (PPRA) rules and neglecting to ensure transparency and circumventing international competitive bidding (ICB). However, if the Chinese company agrees to its demands, Wapda is ready to bypass these rules and play the game.

Wapda has now raised several contentious issues about the project which were not discussed earlier at any level. Wapda now wants to execute the whole project itself or alternatively, become a partner with 51 per cent share in a joint venture with the Chinese.

Wapda had signed an MoU with the CWE for the construction of the project in 2008, reveal documents made available by sources close to the federal Ministry of Water and Power. The Private Power and Infrastructure Board (PPIB) issued a Letter of Interest to CWE and waived procedural formalities.

The CWE updated the feasibility study originally commissioned by Wapda and made a commitment to pay the audited cost. CWE is a multibillion group which owns some 30,000 MW of hydropower capacity including three dams.

The federal government has offered the Chinese company to either construct the project as a contractor or on the basis of Build, Own, Operate and Transfer (Boot). Surprisingly, the CWE opted for the long-term and riskier Boot option under which the project would be handed over to the AJK government after 30 years.

“My announcements should not be taken for pre-poll point scoring. However, it should be clear that If the Chief Minister of Punjab can announce pre-poll packages, so can I. I have a right to do so”, Mehdi Shah stated. He made a number of promises, during his visit, including: entry level jobs to local people, separate seat in GBLA for Gupis and Ishqamen, 4000 new employment opportunities, up gradation of schools, reconstruction of Hayum Bridge etc.

Tariq Naqash, PML-N warns Govt about 'unrest' in PaK

March 23, 2011

MUZAFFARABAD: The Pakistan Muslim League Nawaz on March 22 reiterated its warning to the Federal government about “unrest and law and order problem” in Pakistan occupied Kashmir if

the alleged interference by federal ministers in the region did not stop.

“Let it be very clear that if the federal ministers did not stop meddling in our region we will block their entry and if that leads to unrest and law and order problems we will not be responsible for it,” said Raja Farooq Haider, chief organizer of PML-N AJK chapter at a press conference Muzaffarabad.

Haider, who is also a former PoK premier, noted: “The election drama of 2006 cannot be repeated in 2011. We have to and we will stop it,” he asserted. He called upon the mainstream Pakistani media to give more space to PoK so that the people of Pakistan could know the circumstances election was being held in this sensitive region.

“All we want, earnestly, is that Pakistan should not blot its copybook by interfering in PoK election like India did in Jammu and Kashmir,” he stated. The PML-N, he further stated, was preparing its suggestions and recommendations to be submitted to the election commission for free and fair polls. Haider noted PoK was not a constitutional but de facto part of Pakistan and under the UNCIP resolutions Islamabad was responsible to ensure good governance in this region.

Tariq Naqash, Kashmiri refugees reject 'surrender policy'

MUZAFFARABAD: While rejecting India's “surrender policy,” representatives of Kashmiri refugees in Muzaffarabad on March 13 vowed to continue the struggle, both militarily and politically.

“Kashmiri refugees will play their role in the movement by extending full support not only to the pro-freedom political leadership but also the militant leadership,” stated a resolution adopted at their 'roundtable conference.'

Held in the hall of press club, the conference was attended prominent refugee leaders, including the presidents of 11 major refugee camps in Muzaffarabad.

Participants rejected the surrender policy offered by India to the Pakistan occupied Kashmir based Kashmiri refugees and former militants and said they would continue the struggle till they get their right to self determination. “We won't accept any option or decision that betrays the blood of 500,000 Kashmiris. Instead the freedom movement will enjoy our moral, political and physical support,” the resolution stated.

Shabbir Mir, Gilgit-Baltistan: PAC chief removed from post

GILGIT: A legislator who threatened to blow up the Gilgit-Baltistan Legislative Assembly (GBLA) has been removed from his post after he refused to publicly apologise. Raziuddin, an independent lawmaker, who was appointed chairman of the public accounts committee (PAC) last year, was removed from his post after PAC members Bashir Ahmed, Yasmeen Nazar, Sheikh Nisar and Mutabiat Shah submitted a letter to the speaker, expressing no-confidence in the chairman after his threat.

“The committee has been dissolved with immediate effect after a majority of its members expressed no-confidence in the chairman through a letter,” the speaker of the legislative assembly stated on March 12.

They accused the bureaucracy of weakening the political setup in Gilgit-Baltistan. “We have to go back to our constituencies after all. What will we tell our people?” Haji Gulbar, minister Health and Zakat said.

Limit number of trucks in cross-LoC trade further: Army

SRINAGAR: Over a month after Pakistani authorities requested their Indian counterparts to limit the cross-LoC trade on the Srinagar-Muzaffarabad road to 100 trucks a day, the army has asked the civil administration to further reduce the number in view of security concerns.

“They (army) have asked us to limit the number of

trucks due to security concerns as they have to check goods in all the trucks coming from Pakistan-occupied Kashmir (PoK) which is a time consuming process," deputy commissioner Baramulla Bashir Ahmad Bhat stated.

However, an army spokesperson noted the force has not fixed any specific number for the trucks crossing over the PoK but has requested that it should be within manageable limits. "We have only requested for keeping the number of trucks within the manageable limits in view of security concerns," army spokesperson Colonel V Sood stated. He noted the aim of restricting the number of trucks was to conduct the trade within the time limit set for it.

The cross-LoC trade between the divided parts of Kashmir, which is held every Tuesday and Wednesday has been growing in volume and value and so far goods worth nearly Rs800 crore have been exchanged since it was started on October 21, 2008. The army's "request" to the civil administration comes a month after a similar request from authorities in PoK.

On February 10, the authorities from other side of the LoC had requested their Indian counterparts to limit the number of trucks crossing over to PoK just 50 per day.

JKCHR reminds UNHRC of UN mechanism on Kashmir

LONDON: Jammu and Kashmir Council for Human Rights (JKCHR) has reminded the 16th Session of UN Human Rights Council that sovereignty of a nation confers responsibility to ensure protection of human beings from want, from war, and from repression and that “When that responsibility is not discharged, the international community is morally obliged to consider its duty to act in the service of human protection”, a message from Geneva, Switzerland stated.

JKCHR in its written statement under agenda item 3 on “Promotion and protection of all human rights, civil, political, economic, social and cultural rights, including the right to development” received by the UN Secretary General and circulated in accordance with ECOSOC resolution 1996/31 at the current Session of HRC in Geneva has reminded the HRC of the manner the two sovereign States India and Pakistan and the member nations of United Nations have taken upon a trust obligation in regard to the fundamental rights, habitat and people of Kashmir. United Nations has a mechanism on ascertaining the free will of the people under a mechanism structured by the United Nations. A non-implementation of the agreed mechanism in all the three parts of the State namely Jammu and Kashmir, Azad Jammu and Kashmir and Gilgit and Baltistan has continued to distribute the people and territory, defined in article 4 of the Jammu and Kashmir Constitution. JKCHR Statement adds that “People have been through a massive violation of human rights from early 1990. In fact the numerical deficit in the population of Kashmir caused by the death of a generation has killed the right of self-determination. the twin of Italy's Cortina city in August 2010.

Japan grants US\$ 103,713 for improvement of Water Supply, Sanitation in Muzaffarabad

The grant will be utilized for laying down the pipe lines and constructing four water tanks with ten distribution points to supply safe drinking water to the project area that was badly affected in the 2005 earthquake. The project will also provide sanitation facilities for schools and other public places to improve the hygiene conditions

UN commission asked to assess rights situation in Baltistan

March 23, 2011

WASHINGTON: The UN Human Rights Commission has been asked to send a special rapporteur to visit Gilgit and Baltistan areas to assess human rights situation by a European Parliamentarian. Jurgen Creutzmann, who is the chairperson of the Friends of Gilgit-Baltistan in the European Parliament, has also asked the European parliamentarians to assess the impact of closure of Line of Control on the people of the area. The parliamentarian made the demand at a conference in Geneva organised by the Washington-based Institute for Gilgit Baltistan, where speakers noted

that Gilgit Baltistan areas of Pakistan occupied Kashmir, now carved into Northern territories remained under heavy censorship and brutal oppression. Though the Pakistani regime has promulgating ad-hoc presidential ordinances like Gilgit-Baltistan Self-governance and Empowerment Ordinance of 2009 and Balochistan Reconciliation Ordinance of 2009, Islamabad continues to enjoy veto right over decisions pertaining to financial and judicial matters, he stated. Senge Sering, of the Institute for Gilgit Baltistan requested the international rights organisations to pay attention to the genuine needs and interests of the people of Pakistan occupied Kashmir, Gilgit-Baltistan and Balochistan and pressure Pakistan to withdraw security forces and grant the "natives of these regions absolute right over their land and resources". Mumtaz Khan, executive director of International Center for Peace & Democracy stated that all the decisions pertaining to Pakistan occupied Kashmir are made in Islamabad and even the Kashmiri president and prime minister are denied a say in decisions pertaining to resource exploitation and revenue distribution. He called Kashmir Council "a political tool of Islamabad to enforce veto power over the decisions of local judicial, political, economic and financial institutions" and demanded its immediate abolishment.

It is estimated that well over 700,000 British citizens come from Azad Kashmir. Every year tens of thousands of visits take place between Pakistan and UK, and expatriate Pakistanis are a huge source of strength to Pakistan and its economy, stated Dr Khokhar while addressing a large number of Pakistanis in London. Dr Khokhar informed the audience that he was fully aware of the problems faced by expatriate Pakistanis including cases of kidnap for ransom, police high-handedness, lack of response, tribal-oriented litigation and targeting of the overseas Pakistanis by the criminal gangs including some rotten eggs from within the police service.

Small earthquake jolts northwest Pakistan

KARACHI: A light earthquake of magnitude 4.8 jolted northwest parts of the country near the border with Afghanistan on March 11 but there were no immediate reports of casualties, an official stated. The quake struck at 4:32pm with its epicentre in the Hindu Kush mountain range, chief meteorologist Muhammad Riaz noted. Tremors were felt in several cities in Khyber Pakhtunkhwa and its capital, Peshawar, he stated. The quake hit a few hours after a devastating 8.9-magnitude earthquake hit Japan on March 11 and triggered tsunami alerts across the Pacific Ocean. Pakistan was hit by a 7.6-magnitude earthquake on October 8, 2005, that killed more than 73,000 people and left about 3.5 million homeless, mainly in Azad Jammu and Kashmir and parts of Khyber Pakhtunkhwa. Initiatives to protect the population of snow leopards in the region have proven successful as illegal hunting is targeted by local police but bigger questions regarding dam construction remain.

Initiatives taken some couple of years back in Bunji, a small town some 50 km away from Gilgit, to help increase population of endangered snow leopard have started showing tremendous results as local people claim that population of this fascinating specie has almost doubled in this particular area.

Though no radio collar study has been carried out in this area due to lack of resources but eleven local persons have so far claimed that they have succeeded in looking snow leopards from a close distance in last two months.

The wildlife experts on the basis of statements given by eyewitnesses were of the view that the population of snow leopards in the area has increased up 50 to 60 as compared to nearly 30 some years back.
