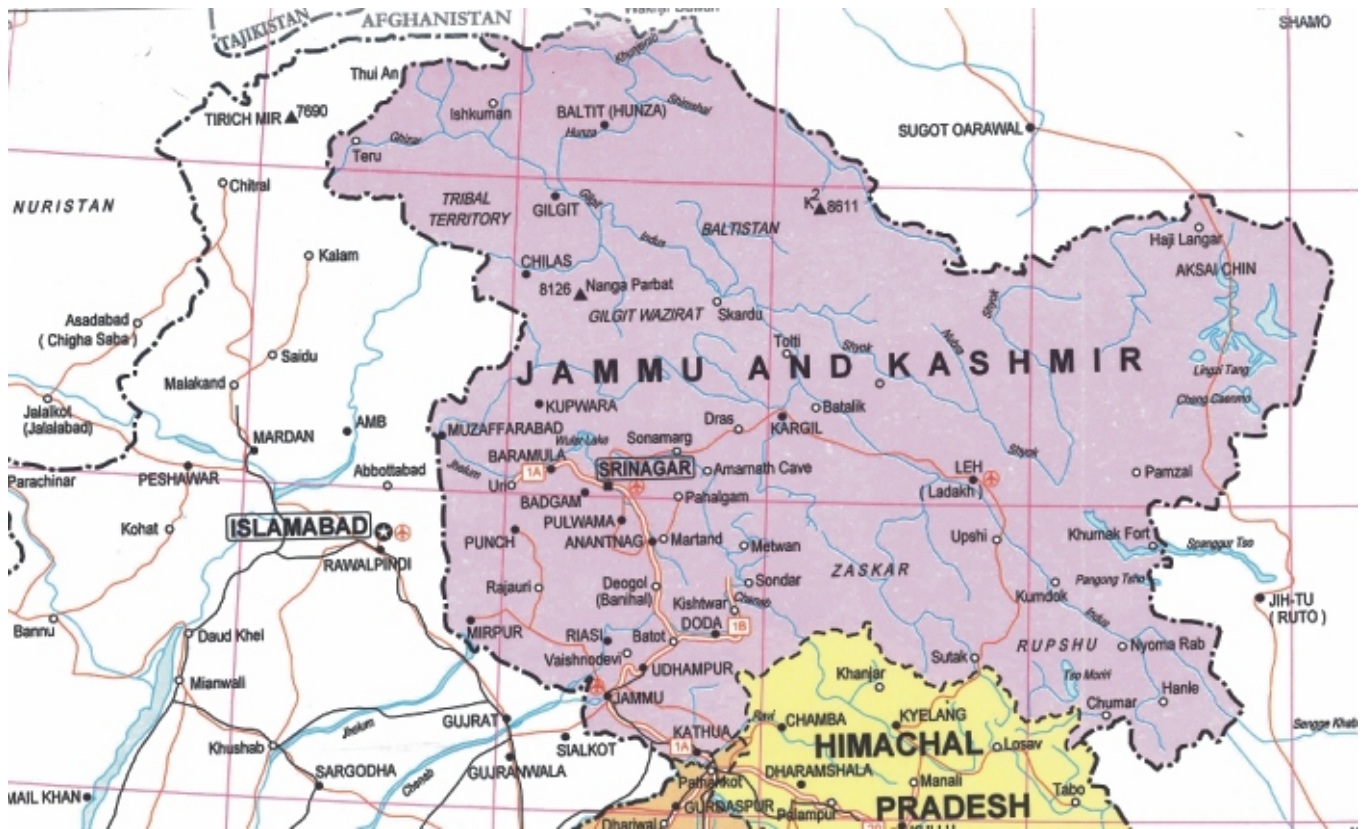

## **In this Edition**

*The much anticipated China Pakistan Economic Corridor (CPEC) worth \$ 46 billion is being referred to as a game changing project that will resurrect the dwindling economic situation of Pakistan. The massive connectivity project will cross through Gilgit Baltistan, part of Pakistan occupied Kashmir, and the only land link between the all-weather allies-China and Pakistan. Since the announcement of the CPEC project, there has been animated debate within Pakistan on the probable route it would take-eastern, western or central and in each case who could be the actual beneficiaries. Simultaneously, there is an emerging concern within Gilgit Baltistan on what the CPEC has in store for the region. The overall lack of transparency in the project allocations within the CPEC and the failure of the Pakistan government to provide a clear road map to Gilgit Baltistan vis a vis the CPEC, has been a source of rising concern amongst local people. Such apprehensions have been voiced by the local political leadership of the region as indicated in reports included in the current issue. Also included in the current issue are reports that show how the Pakistani leadership at the federal level is trying to tide over such concerns by noting that Gilgit Baltistan is crucial to the upcoming strategic connectivity corridor.*

*Despite such assurance given by Pakistan towards Gilgit Baltistan's criticality to the CPEC, fact remains that apart from announcing a couple of special economic zone (SEZs) in the region as part of the CPEC (that too after considerable political pressure was applied from the region), nothing concrete has been finalized yet as far as big ticket projects are concerned. People in Gilgit Baltistan are increasingly becoming wary of the reality that the lack of constitutional and a definite political status will potentially deprive them of benefits accruing from the CPEC.*

*As noted, being the only land link between China and Pakistan, the CPEC could not be conceived without crossing through Gilgit Baltistan territory. Even before the CPEC came into being, Gilgit Baltistan continued to serve as the vital link on which the Sino- Pakistan strategic partnership thrived over several decades.*

## **M A Mir, “AJK premier slaps civic agency official”**

In a bizarre yet telling incident of the strained relationship between the bureaucracy and the executive, the prime minister of Azad Jammu and Kashmir (AJK) Chaudhry Abdul Majeed reportedly slapped an officer of the Mirpur Development Authority (MDA) for his alleged failure to address public complaints, only to call him back to his office and offer an apology when the official threatened to expose the premier and his sons for their alleged corruption. The incident that took place at the PM's residence in Mirpur on January 30 could best be described as an apparent patch-up of convenience between a bureaucrat who has failed to deliver and an executive running short of ideas. Official sources and an eyewitness noted that the rebuke saw the MDA officer threaten the prime minister of spilling the beans about him and his sons' involvement in the affairs of the civic agency and alleged wrongdoings during the last four-and-a-half years. The sources further stated that the MDA Estate Officer Imran Shaheen tried his best to give clarifications but in response he received a slap from the prime minister in the presence of other officers at the meeting.

## **“Gilgit-Baltistan is pivotal to CPEC, says Mushahid”**

A 19-member delegation of the Gilgit-Baltistan Assembly led by Speaker Fida Nashad met Senator Mushahid Hussain Sayed, Chairman, Parliamentary Committee on China-Pakistan Economic Corridor (CPEC) at Parliament House on February 1. The Gilgit-Baltistan Assembly members representing five political parties from both the ruling and opposition parties requested the

meeting to have their perspective on CPEC. According to press release, in the 2 hours meeting which included a lunch hosted by Senator Mushahid Hussain for the visiting members of the GB Assembly, Senator Mushahid Hussain underlined that the CPEC was a national, strategic project spanning 15 years and this project is above any person, parties, province or even government and all the provinces and regions for Pakistan would benefit through CPEC. Referring to the important role of Gilgit-Baltistan in the context of Pakistan-China relations, Senator Mushahid Hussain assured the GB Assembly members that Gilgit-Baltistan is very much part of the CPEC because Gilgit-Baltistan is the gateway into Pakistan for China from its province of Xinjiang. He stated that Gilgit-Baltistan was not just of strategic importance but it had tremendous economic potential for the whole region and he stated that the hydro power resources of Gilgit-Baltistan as well as infrastructure, tourism can change the face of the region as well as Pakistan as a whole. He also stated that Gilgit-Baltistan provides connectivity not only to China but it also provides connectivity to Central Asia through Tajikistan.

## **Zia Ur Rehman, “Kashmir polls fever starts gripping parties in Karachi”**

Political parties become active for two AJK Legislative Assembly seats reserved for Kashmiris living in Sindh. At his office in Quaidabad, Sardar Mufti Naseer Ahmed, a Kashmiri political activist associated with the Pakistan Muslim League-Nawaz, is busy gathering the data of his community members living in the area. For the Azad Jammu and Kashmir Legislative Assembly elections expected in May or July 2016, political parties' Karachi chapters have become active in the city's



Kashmiri-populated neighbourhoods to win the two seats there reserved for the community members and refugees living in Sindh. The LA-30 (Jammu-I) is a constituency reserved for Kashmiris belonging to AJK and it comprises Sindh and five divisions of Punjab. In the 2011 elections, there were 68,000 votes in the LA-30. Around 35,000 of them were in Karachi, noted some Kashmiri leaders in the city. In the last polls held in July 2011, Muttahida Qaumi Movement candidate Tahir Khokhar secured the LA-30 seat by bagging 30,620 votes, defeating PML-N's Abdul Rasheed Mirza, who received 18,301 votes. The LA-36 (Kashmir Valley I) is a constituency reserved for Kashmiris from Jammu and Kashmir who had migrated in the 1940s and 1950s. There are 6,200 voters, including over 4,000 in Karachi, while the rest are in Quetta and the rural districts of Sindh. MQM candidate Saleem Butt had won that seat in 2011 by bagging 4,633 votes.

### **“Rental power case: Remand of former AJK president's son extended”**

An accountability court extended on February 2, physical custody remand of the son of former Azad Jammu and Kashmir (AJK) president for six days to the national anti-graft body. Raja Babar Ali Zulqarnain will remain in the custody of the National Accountability Bureau (NAB). Judge Nisar Baig extended the remand after NAB officials produced him before the court. Zulqarnain was arrested on January 21 from the premises of the Islamabad High Court (IHC) following the dismissal of his bail application in connection with the rental power project case. According to the anti-corruption body, Zulqarnain, who is also an elected member of the AJK legislative assembly, made the contractual arrangement between the federal government and a private company for electricity supply through a ship-mounted power facility. Zulqarnain was appointed to act as the local representative for the Karkey Karadeniz Elektrik Uretim a Turkish company which set up a power plant onboard a ship berthed at the Karachi port to provide electricity to the national grid and logistical

support to the visiting representatives of the company.

### **“Provincial status for GB to imperil Kashmir cause”**

Former AJK Prime Minister Sardar Attique Ahmed asked the Pakistan government not to declare Gilgit-Baltistan as the fifth province of Pakistan, stating that the proposed move would weaken the Kashmir Cause at the international level. He was talking to the different delegations at the office of Pakistan Council for Social Welfare and Human Rights (PCSWHR) during his two-day visit to Sialkot. PCSWHR Chairman Ejaz Noori was also present on the occasion. Sardar Attique Ahmed also stressed a need for promoting true and strong democracy in both Azad Jammu and Kashmir (AJK) and Pakistan. He stated that the strong democracy could help take up the Kashmir dispute at the international forums effectively. He also urged the UN to ensure early implementation of its resolutions for the peaceful solution to the Kashmir dispute as per the aspirations of the Kashmiri people. He noted the Kashmir Issue has reached near its peaceful amicable solution as per the aspirations of the Kashmiri people.

### **“Protests on KKH in Abbottabad banned”**

The district administration decided to declare strategic Karakoram Highway (KKH) limits in the city as 'Red Zone' for holding protests and designated a space at the Jinnah Park for all such meetings. This was decided at a review meeting of traffic management convened in the Deputy Commissioner's Office on February 2. Abbottabad Deputy Commissioner Khalid Mehmood presided over the meeting. The deputy commissioner confirmed the decision to the media and stated a notification would be issued soon. The official noted the strategic highway in Hazara Division

linking it with Gilgit-Baltistan is a lifeline for the upcoming China-Pakistan Economic Corridor project. “We have initiated regular consultative meetings with all the stakeholders including elected representatives, line departments, lawyers, journalists, traders and general public in the last six months to overcome different problems facing the city,” he added.

He also added that the traffic management plan, shifting of van and Suzuki stands inside the city other issues were discussed in length and decisions taken with the consultation of all the stakeholders. He further stated different roads in TMA & Cantonment areas were cleared for smooth flow of traffic and parking places were identified in the city.

### **Shabbir Mir, “Convoy system along KKH ends”**

The convoy system on Karakoram Highway (KKH) was finally scrapped on February 2, putting an end to the travel woes of passengers who frequently take the route. Under the system, which existed since 2012, 50 to 100 vehicles were required to move in groups from Gilgit-Baltistan's Diamer district till Besham, Shangla in Khyber-Pakhtunkhwa. The convoy was escorted by K-P's law-enforcement agencies.

“The decision was taken at a meeting chaired by the Khyber-Pakhtunkhwa chief secretary in Peshawar on February 2,” Usman Ahmad, the DC of Diamer, noted. “It was taken in light of recommendations put forward during a two-day apex committee meeting held in December, 2015.” The decision to end the convoy system would come into effect on February 3. The convoy system created countless challenges for passengers including prolonging their journey. The decision to scrap the arrangement has been hailed by a large number of residents. “Thank God, [the convoy system] has finally ended,” stated Mujeeb Khan, a resident of Chilas.

The political leaders of Pakistan and Azad Jammu and Kashmir (AJK) on February 3 called for finding a solution to the longstanding Kashmir dispute in light of the UN resolutions as they stated Pakistan is incomplete without Kashmir. They also reiterated their resolve to raise voice at international forums to

ensure the Kashmiris get their right to self-determination. This resolve was made during 'Kashmir Solidarity Seminar' held under the auspices of Express Media Group. The seminar was attended by Information Minister Pervaiz Rashid, JUI-F chief Maulana Fazlur Rehman, Jamaat-e-Islami chief Sirajul Haq, AJK's former Prime Minister Sardar Attique Ahmed, Senator Lt Gen (retd) Abdul Qayum Khan, PTI MNA Ali Muhammad Khan and AJK minister Abdul Majid Khan. Addressing the seminar, Pervaiz Rashid stated all the nations of the world and the UN accept that the Kashmir issue should be resolved according to the aspirations of the people of the disputed state. "This reality has also been accepted by India's political leadership which was compelled to visit Lahore. They [the Indian leadership] have expressed their willingness to find a logical solution of the problem," he noted. Rashid stated that in the past the two neighbouring countries came very close to the resolution of the lingering dispute multiple times but always some unseen powers struck at the last moment and succeeded in sabotaging the whole initiative.

### **Tariq Naqash, “Kashmir a litmus test of leaders' foresight: Sharif”**

Prime Minister Nawaz Sharif described the Kashmir issue as a litmus test of the political foresight of Indian and Pakistani leadership and expressed the hope that dialogue would be held soon to resolve the lingering dispute. Addressing a joint sitting of the Azad Jammu and Kashmir (AJK) Legislative Assembly and the AJK Council, especially convened on February 5 to mark Kashmir Solidarity Day, he stated there was a big question mark on the goodwill, prestige and authority of the United Nations because of the Kashmir issue. Though the speech did carry implied notes of caution for India, Mr Sharif by and large adopted a soft and reconciliatory tone. Kashmiri people are demanding nothing but what was pledged to them by the United Nations. The United Nations has to tell the world why it has failed to implement its own resolutions. "This question is not just linked to the Kashmir issue or Pakistan-India dispute, but to the goodwill, prestige and authority of the world body," he noted. Mr Sharif stated Kashmir had been yearning for peace since 1947 and the situation warranted a new thinking in South Asia. History is once again asking the leadership in India and Pakistan that what they will leave behind for the coming generations peace or hostilities?

### **Abid Bashir, “Gilgit-Baltistan will remain part of disputed JK, Pak envoy tells Mirwaiz”**

The Hurriyat Conference (M) chairman Mirwaiz Umar Farooq on February 7 stated Pakistan has not changed its stand on Gilgit-Baltistan and the region shall continue to remain a part of disputed Jammu and Kashmir. "I met Abdul Basit, the Pakistan High Commissioner in New Delhi, and had a detailed discussion on a series of issues including reports that Gilgit-Baltistan is being merged with Pakistan.



The Pakistan High Commissioner clarified to me that there is no change in Islamabad's policy on the issue and that Gilgit-Baltistan would continue to remain the fifth region of the disputed Jammu and Kashmir," Mirwaiz noted soon after his meeting with Basit. Pertinently, JKLF chief Muhammad Yasin Malik and Hurriyat Conference (G) chairman Syed Ali Geelani had written letters to Pakistan Prime Minister Nawaz Sharif seeking clarification on media reports suggesting that Gilgit-Baltistan is being merged with Pakistan. The separatist leaders asserted that if Pakistan would merge the region, New Delhi will have a justification to claim Kashmir as its "integral part."

Journalists who work in tandem with authorities are treated well. But the lives of independent journalists who report Pakistan government's misrule in the region are miserable. Nevertheless, these journalists continue to risk their lives and report about the ground realities of the region occupied by Pakistan for decades.

### **“Disorder prevails as Imran inaugurates PTI Azad Kashmir office”**

Earlier when Imran Khan arrived at the ceremony, disorder prevailed over the event as workers pushed each other to somehow climb the stage. The party leaders pleaded before the workers

### **M A Mir, “Under pressure: AJK poll body gets new chief”**

Justice Ghulam Mustafa Mughal was appointed new chief election commissioner of Azad Jammu and Kashmir (AJK) through a notification. The ruling Pakistan People's Party (PPP) gave in to the wishes of the local apex court on February 11, following a contempt notice issued by the apex court of the region. A notification was issued by the AJK's Ministry of Law, Justice, Parliamentary Affairs and Human Rights hours before the deadline set by the region's highest court. The AJK Supreme Court issued contempt of court notice to the state's government for non-appointment of chief election commissioner. The AJK government, following court notice, issued the notification of appointment of the AJK High Court Chief Justice Mughal as the chief election commissioner. The general elections in AJK are likely to be held in June 2016. “The president of AJK on the advice of Azad Jammu and Kashmir Council is pleased to appoint Justice Ghulam Mustafa Mughal as chief election commissioner. In addition to his duties as such for a term of three years or till his retirement whichever is earlier,” reads the notification. The notification shall take effect from date CEC takes oath of office. ### **Manzoor Ali, “Hiring of 1,300 men proposed for Karakoram Patrolling Force”**

The Khyber Pakhtunkhwa police proposed the recruitment of 1,300 personnel for the Karakoram Patrolling Force to guard the Karakoram Highway portion passing through the province. The force was launched earlier this month, February 1, with 200 personnel hired on contractual basis. According to the relevant officials, the police department, keeping in view the sensitivity of the situation, sent a summary to the provincial government on February 8, 2016, on the creation of the KPF, a new permanent force. They noted the KPF would guard the 390km long stretch of the KKH, which passed through six districts of the province from Haripur to Kohistan and connected it with Gilgit-Baltistan. The available summary notes that the KKH route's strategic importance could not be denied in the backdrop of the current economic and security situation and that both cargo and passenger vehicles moving to and from Gilgit-Baltistan used the highway. It stated the highway was used for hauling supplies to the deployment of the armed forces in the country's northern areas. The summary also stated the same route would also carry immense importance due to the China-Pakistan Economic Corridor project related hydropower projects.

### **“PPP, PML-N activists clash in Azad Kashmir”**

Police resorted to aerial firing, teargas shelling and baton charge to disperse the clashing groups. The injured were rushed to Nakayal and District Hospital Kotli where 4 of them were reported to be in a critical condition. Pakistan Army troops were called to the area to control the situation. A judicial commission has also been established to probe the incident. Chief Secretary of AJK Sikandar Sultan Raja has also taken serious note of the unpleasant incident and directed Commissioner Mirpur Division to hold an inquiry and report to the CS office in the next 24

hours and take every possible step to maintain the law and order situation. The chief secretary also directed deputy commissioner Kotli to take every possible step to maintain law and order. He stated that nobody will be allowed to take the law into their own hands. Meanwhile, the PPP chairman Bilawal Bhutto Zardari has strongly condemned the armed attack on the PPP workers convention in Nakial.

### **“Islamabad tells AJK PM to quit”**

But the CDA along with Rawalpindi police repeated the incident late night on the same day by demolishing the arch and gate, and violated the sanctity of the shrine," the PM noted in the letter. The AJK PM stated that the late Kashmiri leader was the founding member of All Jammu and Kashmir Muslim Conference and

supreme head of Azad Kashmir Liberation Movement. He was champion of Jammu and Kashmir State's accession to Pakistan and after death in 1967 he was buried in then Rawalpindi according to his own will, as he had earnestly believed in integral relationship of Pakistan and state of Jammu and Kashmir, the letter added. He also stated since 1967, the land of the shrine remained undisputed and the premises was demarcated with the gate along with arch intact.

## **“Government, AJ&K agree to raise power tariff”**

*Business Recorder, February 8, 2016*

Federal government and Azad Jammu and Kashmir (AJ&K) have agreed in principle to increase power tariff by 123.5 per cent from Rs 2.59 per unit to Rs 5.79 per unit in lieu of increase in Water Usage Charges from Rs 0.15 per unit to Rs 0.425 per unit to be effective from July 1, 2015, sources close to Secretary Electricity, AJ&K noted. AJ&K owes an outstanding amount of Rs 60 billion to power Distribution Companies (Discos) since long as Muzaffarabad is not paying a single penny in this regard. Secretary Electricity AJ&K, Fayyaz Ali Abbasi, in a letter to the federal government has cited the minutes of a meeting held on December 23, 2015. According to him, the draft minutes were shared with the Prime Minister of AJ&K who has accorded approval for the following: (i) The power tariff for AJ&K will be Rs 5.79 per unit from July 1, 2015 till next tariff determination; (ii) the issue of arrears will be taken up with the Ministry of Water and Power and Finance Division separately; and (iii) section 2.3 & 2.3.1 of the draft trio-partite agreement hydropower project will be replaced as "the Wapda shall pay to the AJ&K Net Hydel Proceeds/ Water Use Charges/ royalty from Neelum Jhelum Power Project with effect from the Commercial Operational Date (COD) of the project at Rs 0.425/ KWh provided that Wapda shall also be liable to pay any upward enhancement approval in case of KPK or other provinces of Pakistan in future". AJ&K has also communicated to the federal government that Power Purchase Agreement (PPA) for Jagran-1 HPP will be signed with the Central Power Purchasing Agency (CPPA) and tariff approval from National Electric Power Regulatory Authority (Nepra) will be obtained.

## **MA Mir, “Kashmir traders meet on LoC”**

Traders in the divided Kashmir valley seemed more interested in exchange of goods than exchange of fire between Pakistan and Indian forces, as they demanded more pints of trade on the Line of Control (LoC). Following a gap of one year, businesspeople from Jammu & Kashmir and Azad Jammu and Kashmir (AJK) braved freezing temperatures and light rain to meet halfway on Chakoti Bridge on February 10 to discuss trans-LoC trade and travel, sources noted before the media. After a two hour meeting, the traders jointly released a charter of demand that was made available to the media. The charter, among other demands seeks, more trade routes on LoC, multiple entry permits for traders, lifting of ban on items such as pulses and herbs, inclusion of more items in the trade list, daily bus service between Muzaffarabad and Srinagar and tourists' visit on both sides of LoC.

## **Shabbir Mir, “Import, export hub: 15 traders' bank accounts frozen at Sost branch”**

The bank accounts of at least 15 traders were frozen for their alleged involvement in the embezzlement of Rs220 million at a branch of National Bank of Pakistan (NBP) in Gilgit-Baltistan. “Their accounts will remain frozen until the enquiry comes to a

close,” an insider privy to the development noted on February 9. “A letter to the bank has been dispatched.” The traders were accused of working with two bank officers to embezzle the amount from an NBP branch in Sost village, the last town of G-B's Gojal Valley on Karakoram Highway before the China border. “The traders are being investigated by a National Accountability Bureau official,” he added, adding the traders include members from G-B Chamber of Commerce and Industry. The scam was unearthed in January 2016 after a manager and two other officials of the bank were arrested by NAB for embezzling millions and causing a loss to the national exchequer. Over Rs10 million have so far been recovered from them during investigations. According to officials familiar with the matter, Sost town is a business hub as the dry port is located there and bank officers regularly deal with traders involved in export and import with China.

Barjees Tahir further stated it had been decided to meet other finances requirement for upgrading the network and other equipment from the Universal Service Fund (USF) of AJK&GB. Owing to the absence of modern internet facilities in the AJK and GB, people of the two regions could not develop their skills in different sectors, especially education and health.

The United States is tacitly supporting Chinese investments in Pakistan Occupied Kashmir and even those at Gwadar port, say sources. The revelation comes at a time when the Barack Obama administration has decided on selling eight F-16s to Pakistan ignoring India's displeasure. US envoy to India Richard Varma stated that the Chinese investment in Gilgit Baltistan region needs to be watched carefully. "I know the Chinese investment in the region has been a source of disagreement and contention. I think we have to watch this carefully. The fact is that at least in Afghanistan for example, lot of investment in infrastructure and energy and health is needed. So civilian investment is welcome." "I understand the concern about the transport corridor and I understand the concern about other elements of that cooperation that could cause security risks. We are watching both very carefully," he added. Meanwhile, in a move that is bound to raise hackles in India, Pakistan is working on raising the constitutional status of its occupied Gilgit-Baltistan to address China's concerns over the \$46-billion economic corridor through the strategic region. The strategic region in the north provides the only vital link with China. It is also on the key route of the ambitious China-Pakistan Economic Corridor (CPEC), linking western China to southern Pakistan's Gwadar Port with a network of roads, highways, railways and investment parks.

Pakistan People's Party Gilgit-Baltistan President Amjad Advocate criticised both provincial and the central government for snatching the land of the people by force. Castigating Pakistan, he noted that Pakistan took away billions of rupees from the Sost post every year in terms of different taxes and duties.
